ORDER:

World Health Organization (WHO) has declared recent Corona Virus Disease (COVID-19) pandemic affecting all the regions of the world as Pandemic. WHO also classified risk assessment as Very High at the Global level. In this context, Andhra Pradesh has strengthened the surveillance for containment, control and prevention of COVID-19.

The Government of Andhra Pradesh has empowered certain officers of the State Government to take all such measures as may be necessary to contain spread of the said Virus in the State and in exercise of the powers conferred under Section-2, 3 and 4 of Epidemic Diseases Act, 1897 issued “the Andhra Pradesh Epidemic Disease COVID-19 Regulations 2020.” To effectively enforce the Regulations regarding COVID-19, the District Collector vide reference 1st cited has formed a committee to oversee the arrest of the spread of the virus in the District.

At present the Covid-19 is in the second stage of the spread and the third and fourth stages are crucial where exponential spread occurs and the disease becomes a “PANDEMIC”. The District shall have suitable arrangements to meet the challenge of the Pandemic. Accordingly the District Collector has instructed to arrange quarantine centers with a capacity of at least 100 capacity. In this regard, the building complex of **Government Degree College, Uravakonda Town and Mandal** is hereby declared as a quarantine centre to accommodate the suspected COVID19 symptomatic persons till the virus subsides.

Further the following officers and staff are hereby allocated with the duties of overseeing in the above quarantine centers. The Nodal Officers concerned are requested to look after, monitor each and every thing and make sure all the arrangements in centre are to be done.
